ORDER ABOLISHING COVID RESTRICTIONS AND OTHER UNLAWFUL MEASURES

IT IS DECLARED BY THE COURT that the statutory regulations that restrict free movement and association, impose mandatory quarantines and distancing, and require the wearing of masks are unlawful, unwarranted and medically unsound measures that violate the fundamental liberties, health and security of the people.

THEREFORE, IT IS ORDERED BY THE COURT that these measures have no authority and are declared to be null and void, and that no one is obligated or required to comply with the said measures.

IT IS FURTHER ORDERED BY THE COURT that anyone who attempts to enforce these unlawful measures on others is violating this COURT ORDER and is engaged in a criminal conspiracy against the liberty and wellbeing of the people, and as one engaged in a crime is subject to penalties and imprisonment upon conviction.

ORDER PROHIBITING AND CRIMINALIZING MANDATORY VACCINATIONS

IT IS DECLARED BY THE COURT that any statute, regulation or action by any power that requires or imposes mandatory vaccinations on anyone violates and threatens their health, safety and liberty as well as the internationally recognized legal right of informed consent that governs all medical procedures. (*Nuremberg Code, 1947*)

ACCORDINGLY, IT IS DECLARED BY THE COURT that no-one is obligated to consent to or receive mandatory vaccinations, regardless of what authority or person is ordering or compelling such vaccinations.

THEREFORE, IT IS ORDERED BY THE COURT that any individual, body corporate or agent thereof that requires or imposes mandatory vaccinations on anyone is partaking in a criminal conspiracy against their life, wellbeing and liberty, and as one engaged in a crime is subject to penalties and imprisonment upon conviction.
